Art work needs to be delivered by the artist to Novotel Twin Waters on Sunday the 2nd of December 2018 between the hours of 9:00am and 12:00pm unless otherwise negotiated.

Any unsold artworks will need to be collected by the Artist on the last day of exhibition, Friday 7 December 2018 between 1:00pm and 4:30pm

Artwork

- Maximum size for individual paintings 100cm X 100cm unless otherwise negotiated
- Art work needs to be ready to hang
- Copy of artist entry form attached to each piece
- Loose canvas or work on boards cannot be accepted
- NuunaRon reserves the right to restrict the number of artworks per artist

EXHIBITION TERMS AND CONDITIONS

NuunaRon will cover all costs of the exhibition including:

- Venue hire
- Catering for opening
- Welcome to country
- Invitations and promotion
- Hanging and labelling
- Artwork Sales

All care will be taken in handling individual art works however Nuunaron cannot take responsibility for damage or theft by third parties.

Commission
